1. Overview

This document is a master compilation of all OneDrive items referencing Keisha Russell, organized by category for use as a personal legal and records reference. All files and folders were identified through a comprehensive search of Cory Russell's OneDrive account and have been catalogued below with associated metadata including file sizes, modification dates, and content descriptions where available.

The inventory spans a period from **2006 through 2026**, capturing approximately **39+ files and folders** across a wide range of document types including legal filings, financial records, credit reports, audio and video recordings, text message screenshots, and personal notes. All source files remain in their original OneDrive locations; this document serves exclusively as a consolidated reference index.

6. Notes & Observations

- Two separate "**Keisha USPS Mail**" folders exist — one nested inside "Keisha Docs" (primary) and one at a higher directory level. Both are dated March 4, 2021.
 - Two separate "**Keisha Docs**" folders exist — one archived from October 31, 2019 and one primary from March 3, 2021. The 2021 version is more comprehensive.
 - The "**All USPS Mail.pdf**" is exceptionally large at approximately 362 MB and likely contains a comprehensive, multi-year USPS mail tracking history compiled into a single document.
 - Three copies of the **Executed Final Mod Agreement** (dated July 23, 2020) are stored in the Keisha Fraud folder — all showing identical file sizes (~780 KB) and the same modification date of August 9, 2022. One has a variant filename beginning with lowercase "x" suggesting a possible download artifact.
 - The **Keisha - 2026 folder** contains two identically-sized PDFs (*Document 1.pdf* and *scan.pdf*, both 506,340 bytes). These are likely duplicates or the same scan saved under two names.
 - Several **Facebook screenshots** from August 10, 2025 exist in multiple formats: original JPG, a numbered variant JPG, an edited JPG (saved November 1, 2025), and a PNG version (saved November 21, 2025).
 - The file **RSCN2378.JPG** appears twice as exact duplicates (same date: June 27, 2007; same size: 387,915 bytes). One copy can be safely removed.
 - The **Returned Sorority Dues.msg** is unusually large at approximately 5 MB for an email, suggesting substantial attachments are embedded within the .msg file.
